1. CALL TO ORDER

2. EXECUTIVE SESSION SUMMARY

6. COMMITTEE REPORTS

a. Gate Operations Committee – Deb Seror, Co-Chair

The Committee reported on the recent completion of the Long Valley monument project, as well as the Committee's attempt to address the traffic at the Round Meadow gate while school is in session. It was reported that the School Administration indicated they do not presently favor changing the traffic pattern. The traffic issue will be revisited again later in the school year. Also, the Burbank pedestrian gate is on hold until after they get through the launch of Proptia. Proptia officially launched on Sunday, August 13th and the Committee addressed the issues resulting in the backup at the gates this morning. Members were reminded to register with Proptia, as of this date less than half the membership had registered and added their guests.

b. Technology Committee - John McGinnis, Chair

In conjunction with the report provided by the Gate Operations Committee, the Technology Committee also reported on the recent Proptia launch and the issues experienced at the gates that caused traffic to back up in the morning.

c. Report on City Council Meeting – Eric Epstein, Board Liaison

Board liaison Eric Epstein introduced Hidden Hills Mayor Steve Freedland who reported that the funding plan for the City-wide fiber to the home project was discussed at the July 24th Special City Council meeting.

d. Equestrian Services Committee – Anne Kolbe, Chair

The Committee reported on the status of the Spring Valley arena repairs. The vendor is 1-week behind in completing this arena due to issues with the base that were discovered. Once completed, work at the Saddle Creek arena will begin. The Committee also reported on the dog show hosted by ESC on July 23rd.

e. Parks and Recreation Committee – Tamika Watkins, Committee Member

The Committee reported on the final BBQ of the season held August 11th and improvements the Committee is looking to make next year. The Committee also reported on a showing of "A Star Is Born" at this month's movie night. The Committee is working on a Halloween and Seniors event. The Crossroads Kitchen sponsored event is scheduled for Friday, September 8th with a piano performance by Jake Justice. Information on ticket sales will be going out within the next couple of weeks.

f. Theatre Committee – Tamika Watkins, Committee Member

The Committee reported on the Jaxx children's production of "Into the Woods." Performances are currently scheduled for January 12-14, 2024. Information on registration sign-up will be going out in the next couple of weeks.

g. Landscape Committee - Steve Weber, Chair

The Committee reported on the necessary removal of 5 dead trees located at the Spring Valley arena and a few along Long Valley Road. The Committee is looking to plant new trees once the weather cools, hopefully in the month of October. Lynne Burns from Seed Landcare was also in attendance to report on landscape maintenance updates.

h. Architectural Committee – Ryan Levis, Architectural Consultant

On behalf of the Committee, Architectural Consultant, Ryan Levis reported that the August Architectural Committee meeting was scheduled for Tuesday, August 29th. There are over 20 projects on the agenda for architectural review.

a. Recall Petition submitted by the HHCA Membership

On July 25, 2023, HHCA was presented with a recall petition, signed by 5% of the membership, to recall Board President Joe Bellissimo from the Board. The petition signatures were verified. This is a planned project for the 2023/2024 fiscal year and a budget reserve item. Total Cost = \$102,660.00.
