6. COMMITTEE REPORTS

a. Report on City Council Meeting – Eric Epstein, Board Liaison

The installation of the fiber conduit is complete.

b. Equestrian Services Committee – Anne Kolbe, Chair

The committee reported on the recent vaulting event and upcoming carriage demonstration event. The committee is working on their proposed annual budget to include more equestrian events and needed repairs to the footings in the arenas.

c. Roads Committee - Erin Tudron, General Manager

General Manager Erin Tudron provided an update on the pending Jim Bridger/Ashley Ridge road project. The contract is under revision for formal execution. A start date for the project will be forthcoming.

d. Gate Operations Committee - Jeff Korchek, Chair

The committee reported on member Michael Imberman as an upcoming committee member pending a future opening on the committee. "No Truck" signs have been ordered for the Round Meadow Gate and the committee is working with the City to coordinate truck access and signage placement. Co-chair Deb Seror will be reviewing the pre-construction checklist.

e. Parks and Recreation Committee - Tamika Watkins, Co-Chair

The committee reported on the upcoming Welcome Party scheduled for Saturday, May 20, 2023. The theme is "Havana Nights" and is scheduled from 6pm-10pm. Monthly movie night in the Community Center Theatre is still ongoing. The committee is discussing plans for a kids' party.

The committee is working on other event ideas such as a Hidden Hills Got Talent show and introducing a pre-recording before events on theatre etiquette. motorized vehicles on the bridle trails as they can easily spook a horse and cause harm to the horse, the rider and any bystanders. Bicycles are also prohibited on the bridle trails. Additional discussion took place concerning the unauthorized operation of gas powered bicycles/scooters on the streets of Hidden Hills.

f. Proptia Project Status and Update

General manger Erin Tudron and Technology Committee Chair John McGuinnis reported on the current beta testing of the Proptia software in conjunction with the hardware at the gates. A tentative go-live date is anticipated for Memorial Day weekend, but the project is not to be rushed. More information will be forthcoming.
